Methods and material for containment and cleaning up: Scoop up large quantities after dusting surfaces with sand or Fuller's earth to prevent sticking. Sweep or scrape up the spilled material and place in an appropriate chemical waste container. Clean any slippery coating that remains using a detergent / soap solution or another biodegradable cleaner. Apply sand or other inert granular material to improve traction. Further information: Exhaust vapours. Eliminate all sources of ignition. Consider explosion protection. Observe notes under section 7.
